At the first stage of production, solvents 1 and 2 are charged into a high speed mixer. Add other items while running low speed. At the next stage of production, the remaining components are added to the mixture, and all that is mixed in closed boilers that are controlled by a computer. Then the product is poured into containers, in which it is delivered to the production line. During all production stages, the product is tested on various indicators: drying time, uniformity of application, gloss, resistance to damage, color, abrasion resistance, etc.
